

## **MINUTES**

### **Regular Morning Meeting**





#### CALL TO ORDER AND PLEDGE OF ALLEGIANCE

#### **ROLL CALL**

Mayor Pederson, Councilor Hill, and Councilor Palmer were present. Councilor Pettie was not present.

#### CONSIDERATION AND APPROVAL OF AGENDA

Councilor Palmer motioned to approve agenda. Councilor Hill second. Motion passed.

#### **PUBLIC FORUM**

This is an opportunity for citizens to present items to the Council that are not on the agenda. Each presentation is limited to three (3) minutes and a maximum of fifteen minutes is set aside. If your item needs follow-up from the City, Staff will arrange for that.

Mayor Pederson opened Public Forum. Second call made. Public Forum closed.

### a) PUBLIC HEARING FOR FEE SCHEDULE ORDINANCES

Councilor Hill discussed adjustments to fee schedule and listed the items. Administrator Hildebrand suggested approving fee schedule and then amend it later. Mayor Pederson stated to make the changes and have the corrected fee schedule on the February 7th Agenda for approval.

# b) DISCUSSION REGARDING PINE CITY LIBRARY CONTRACT AND BUDGETARY EXPENSES.

Councilor Palmer suggested sending the library what the city budgeted and allow the library to keep track of their expenses. Council approved library expenses for cleaning through February. Council is reviewing the contract. Library contract discussion and possible approval is set for 02/22/24 Council Agenda. Mayor Pederson stated that the library is an asset to our town. Councilor Palmer stated that the library contract needs to benefit both parties.

# c) DISCUSSION REGARDING RESOLUTION 20231220-45 AND A POTENTIAL DISCUSSION REGARDING CONTRACTED FIRE SERVICED BETWEEN THE PINE CITY FIRE DEPARTMENT AND THE CITY OF RUSH CITY.

Chief Miller defined the cancellation of mutual aid. Councilor Palmer suggested billing contractually, including water rates, and have this be across the board to work both ways. Suggested using DRN rates for statewide mutual aid. Rough draft and finalization of contracted aid billing schedule to council by 03/06/24.

Councilor Palmer motioned to appoint Mollie Davis to Ordinance Review Committee. He also suggested that Ms. Davis attend a future council meeting to make introductions and hear her goals for being on the committee. Councilor Hill second. Motion passed.

### c) DISCUSSION AND POSSIBLE COMMITTEE APPOINTMENT

Council invited the resident to attend the three committees that he stated he was interested in and see which committee he liked best. Council would consider moving forward with appointment to a committee once he decided which committee he was most interested in.

Mayor Pederson motioned to approve. Councilor Hill second. Motion passed. Dog Park Open House set for Spring 2024.
