CALL TO ORDER – Council President Steve Ovick called the meeting to order at 10:00am

PUBLIC FORUM – There was a call for public comment but hearing none the public forum was closed.

CONSIDERATION AND APPROVAL OF AGENDA – Councilor Sloan made a motion to approve the agenda. Councilor Pettie seconded. Motion carried.

CONSIDERATION AND APPROVAL OF MINUTES – December 1, 2021 – Councilor Pettie made a motion to approve the minutes. Councilor Palmer seconded. Motion carried.

Item (a.) Pine City Pioneer Bid has been tabled until the January 5, 2022 meeting. A motion was made by Councilor Palmer to approve the remaining consent Items as

presented. Seconded by Councilor Pettie. Motion carried.

UNFINISHED BUSINESS - 20 year warranty transferability for roof repair. It was discussed that a warranty has been approved and that the details of that warranty will be coming soon. It was decided that this item should remain on the unfinished business section of future agendas until the details of the warranty have been received.

NEW BUSINESS –

a. Ehler's Financial Management Presentation. Informational presentation and no action taken.

b. Pine City Historical Society Request. Don Stoffel from PCHS has requested \$300 for materials for a new display at the Room of Villages at the Museum in Askov. *It was discussed that \$1000 had already been budgeted for PCHS and that this request could be earmarked out of that money.*

c. Waste Management RFP. *Councilor Ovick made a motion to approve WM proposal. Councilor Palmer seconded. Motion carried.*

e. Don Julio's Pine City 2022 Liquor License. A request by staff was made to allow the \$2200 paid to the City in 2019 for the liquor license be applied to 2022 waiving the fee for the 28 days in 2021 that the restaurant was operational. *Councilor Palmer made a motion to allow that money to be put towards 2022 license. Councilor Sloan seconded. Motion carried.*

f. Fire Chief Position. There was a discussion regarding the final approval of the full time Fire Chief position and salary. *Councilor Sloan made a motion to approve the position and proposed salary. Councilor Pettie seconded. Motion carried.*

g. Fire and Life Safety Inspector Position. Discussion was had regarding the posting of the new position and the job description language. With the addition of adding blight and city ordinances and policies Councilor Ovick made a motion to approve the posting. Councilor Pettie Seconded. Motion carried.

h. Discussion of OSHA consultation. City staff participated in a consultation from OSHA to get an idea of where the city is if an inspection comes up. Overall, the city did well with a few minor changes to be made with record keeping and a few minor changes to be made at public works, the bottle shop and the fire station.
